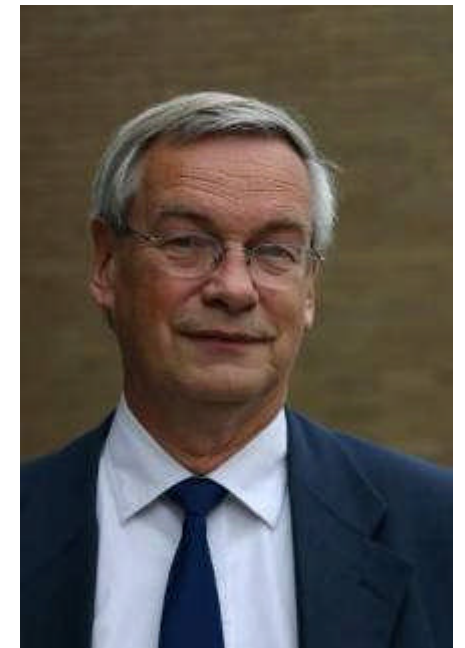

## **SCIENCE AND THE URANTIA BOOK**

### **News article from the Associated Press. November 2006**

VATICAN CITY - A Vatican cardinal said Thursday the faithful should listen to what secular modern science has to offer, warning that religion risks turning into "fundamentalism" if it ignores scientific reason.

Cardinal Paul Poupard, who heads the Pontifical Council for Culture, made the comments at a news conference on a Vatican project to help end the "mutual prejudice" between religion and science that has long bedeviled the Roman Catholic Church and is part of the evolution debate in the United States. Evolution may be slow but is undeniable.

The Vatican project was inspired by Pope John Paul II's 1992 declaration that the church's 17th-century denunciation of Galileo was an error resulting from "tragic mutual incomprehension." Galileo was condemned for supporting Nicolaus Copernicus' discovery that the Earth revolved around the sun; church teaching at the time placed Earth at the center of the universe.

**9** P.1850:8 AD 30 Jesus talked about the "Grace of Salvation." He retold the parable of the lost sheep, the lost coin, and his favorite of the prodigal son.

**10** P.1687:2 AD 29 After the 3rd preaching tour, Jesus' followers assembled at Bethsaida as sober, serious, and disillusioned preachers

**11** P.1858:1 AD 30 Jesus' last sermon at Pella. It embraced a full and complete discussion of the kingdom of heaven.

## **MEMBERS OF PAKISTAN STUDY GROUPS NEED YOUR HELP**

This message was received from Nadia Gill, a Urantia Book reader, concerning the tragedy of the earthquake in Pakistan. Nadia is from Pakistan. She attended the Parliament of the World's Religions in Barcelona in July 2004. She is an unsung heroine in her twenties, a true leader who is passionate about the Urantia teachings. At great personal risk, she has spread *The Urantia Book* to over 40 young people in Pakistan and devoted herself to nurturing study groups. In this patriarchal Muslim culture a woman *and* a teacher of epochal truth is in danger. But she is smart and has deftly managed to stay out of prison. Today, she faces the greatest challenge of her young life. She speaks of her own possible death and the urgency of getting the truth out to as many people as possible in case she dies. Carrying her beloved Urantia Book, she proclaims the love of our Father God and the brotherhood of man to comfort victims.

The Earthquake in Pakistan is not over. People continue living in terror in appalling circumstances with little or no medical help or aid. Nadia has made good use of the funds sent to help the victims who are Urantia book readers. But she needs more. Please read a shortened version of Nadia's most recent plea for help.

In an email from Nadia Gill, she wrote, "I was in the affected area for three days to meet my other Urantian sisters and brothers who are suffering very badly. It is a bad destruction there! Very bad Earth Quake! It really shook me! I am feeling so sorry for them. They lost everything! One of my great and sweet Urantian friends, who is running a small study group is alive after 5 days, buried in the rubble. She has a broken leg. All of my group members have lost their homes and a very intelligent friend who is about 21 years old lost his parents.

I am not fine after seeing my all sisters and brothers in trouble. This study group is a new group and they were progressing very fast! This first study group (outside my town) was showing me very much interest and requesting me to visit them twice or thrice a month. I am very sad!

My Urantia study group in Muzzafarabad lost all their Urantia Books too! I took two Urantia Books with me as I told you that I am always carrying my hard cover UB everywhere, so I had two extra books and my Urantia book readers in Muzzafarabad (affected area) asked me to give them one book so they don't know the bad time and can die reading as much as they can. I gave one book to them and the other book was given to the news reporter from CCNB news.

It is getting cold with snow falling. I bought 50 water proof tents for the earth quake victims, candles, matches, ready made food, water, blankets, warm clothes, medicines etc. I tried very hard to bring my Urantian sisters and brother to stay with us but they refused. They want to be with their own people. We have no more funds to take care of these Victims. They still need lots of stuff.

I am feeling so sorry that I wrote about it to many Urantian friends to help us in this hard time. Our people really need us! Again requesting you all to help us! We really need help because we don't want to lose our friends and other country fellows. This is a very tough time. Please if you can try for funds! Victims are waiting for us! In Father's Love, Your sister in faith, Nadia.

## **UAUS NEWS**

The annual meeting of the Council of Local Presidents (CLP) was held at Hotel Monteleone in New Orleans, Louisiana on August 3, 2005. Thirteen of the local associations, including those as far away as Puerto Rico and Hawaii, had representatives at the meeting. Gary Rawlings, UAI Membership Chair from England also sat in as a guest during the meeting.

President Benet Rutenberg, in his first UAUS meeting as President, welcomed everyone to New Orleans and to the continuation of the work of UAUS. Benet recognized Judy Van Cleave, UAUS Secretary, for her years of service and devotion to this organization saying that, "In the short time we have worked together, I realize what a vast resource she is and has been. I will truly miss her as to replace her will be a near impossible task. So I ask

all for their help and input in this task of finding one who will follow in Judy's example and keep us all informed and on our toes so as to be the best we can be." Judy's term as Secretary will soon expire so nominations for that position are being accepted.

Benet went on to say that membership has its privileges. It has its responsibilities too. There is much more we can do at the national and international level if we have the financing to do so. Item 32, concerning guidelines for joint projects with any non-IUA organization in terms of doing conferences or other endeavors is now the policy of UAI. The UAUS submitted this proposal to the Representative Council and it passed easily with only two no votes.

All CLP Members were urged to become more active on UAUS email list. Everyone's input is needed and desired. He extended an invitation for all good and fully baked ideas from the CLP for consideration by UAUS GB.

The UAUS offered an amendment to Item 33 before the RC concerning the possible changing of the IUA name to UAI. [This has since been passed by the RC]

New persons are to be assigned to the duties of Publications and Website in the near future. We are open for volunteers. There is a proposal for website updating from Rick Lyon and James Woodward, our Education Chair. Benet thanked Janet Quinn for her continued service to UAUS Messenger. We continue to value and be grateful for her service. And to Morris Kaplowitz, who has worked and supported the website, with little help or assistance, for the last several years. We will miss you Morris but know that you are working on other projects at this time. Thank you both very much.

Secretary Judy Van Cleave was appointed administrator of the UAUS online list a couple of months ago; Benet Rutenberg is the list moderator. Judy expressed her appreciation for the "supreme privilege of serving UAUS for the past 3 years, and of serving along with some fine GB members." She said, "The skills, talents and unique gifts I have encountered among them, have truly been a boon in learning and growing for me. From serving alongside Lee Armstrong, Connie Greene and Mike Wood in Chicago 2002, to Lee Armstrong, Connie Greene and David Linthicum in Nashville 2003, to Lee Armstrong, Steve Shinall and David Linthicum in Chicago 2004; and finally to Benet Rutenberg, Steve

Shinall and David Linthicum in New Orleans 2005, these teams have invigorated, challenged and encouraged me. And they have all been a pleasure to team with.”

In researching venue options for the 2007 UAUS conference, Co-Conference Chair Jan Bernard decided to look for retreat centers rather than universities for more comfortable and interesting accommodations. She is consulting with UAI Conference Committee chair, Eddie King, about procedures for conferences.

The Education Committee of UAUS, chaired by James Woodward, has been quiet at the surface, but there has been a good deal of planning activity taking place. After recruiting some qualified members, he began to search for ways to make this committee actually do some educating. A quick survey reveals that a major underdeveloped and underused resource of UAUS is its website. After a series of discussions with Morris Kaplowitz, our esteemed webmaster since he inaugurated the site, it became clear that he did not have the time to devote to a much needed renewal effort – he is very involved in UBIS service duties. Nevertheless, we owe Morris a great deal of gratitude for all his years of volunteer work, which continues in his publishing of the newsletter.

To implement and operate this new site James has done some recruiting and hopes to have a team of volunteers organized soon. We plan to offer new features and content, especially that of an educational nature. It is his goal to that the UAUS should be a leading force in the fields of education, secondary works, leader training, and dissemination. A reinvigorated website will be the primary vehicle for this.

Publications Chair Janet Quinn’s reported that UAUS Messenger Editor, Rebecca Oswald gave notice that she would be vacating her editor position. Morris Kaplowitz graciously agreed to assume editorship duties. Morris has recently declined to serve further as Messenger Editor due to increased family demands. I have asked Chris Bailey to assume Messenger editorship, and she has agreed. Chris will be capable and energetic in this post, and we are looking forward to working with her during the next year. We hope to stir increased enthusiasm to all UAI members to submit relevant articles for upcoming issues of the UAUS Messenger.



Ways of conducting electronic business meetings were discussed to replace conference calls and the resulting long distance charges.

Secretary Judy Van Cleave emphasized that the new UAI database is an important tool that needs tending and updating by each local association governing board – sooner rather than later.

Nominations are now open for UAUS vice president and secretary. Steve Shinall is completing his first term as vice president and regrets that he will not be able to serve for second term. Judy Van Cleave is completing her second term as UAUS secretary and is ineligible for re-election. Nominations must be made through local association presidents and must be accompanied by a biography and goal statement. ## ***STUDY GROUPS AROUND THE WORLD - INDONESIA***

*The Urantia Book* study group Prana Cipta Urantia Indonesia wishes to thank those of you that have given aid in the form of copies of *The Urantia Book*. This group recently received 10 books and they will be receiving 6 more. Keluarga Besar Nitiprana says that these books are very meaningful because this study group has 32 members but they only have 2 books to share among them. Their study group time is divided into two meetings: Study Group I (Prana Cipta Spiritual), which started in 1992, and Group II ( Prana Cipta Urantia Indonesia), which began in 2002. Keluarga describe the groups in a recent email:

### **Study Group I (Prana Cipta Spiritual): 132 people**

*The Urantia Book* knowledge takes away from: Bible, Qur'an, Veda, Buddhist, and other religious books. Our study group consists of 60% Moslem, 30% Christian, and 10% Buddhism and Hindus. We have never had a problem of religion because we study moral and spiritual problems. In our group study, one of the instructions concerning procedure is to open our "spirit eye" to recognize and see "The God Messenger" existing in the human being itself (in *The Urantia Book* referred to as The Adjuster). After they learn to recognize "The God Messenger" (The Adjuster), we introduce *The Urantia Book* to them, and follow up with study of *The Urantia Book* in Study Group II (Prana Cipta Urantia Indonesia).

### **Study Group II ( Prana Cipta Urantia Indonesia): 32 people**

One of the constraints which we face at this time is that there is no Indonesian translation of *The Urantia Book*. Nugroho Widi of Jakarta is working on this translation for the Urantia Foundation. In this Study Group II, only about 40% understand English. At the moment we are comprehending knowledge about The Adjuster and human being's journey to the Father in Paradise.

For us, *The Urantia Book* is of vital importance as additional knowledge about The Adjuster in *The Urantia Book* adds to our confidence that God with His love gives His Spirit to every human being and that can be proved manifestly. ## ***UAUS CONSIDERS BYLAW CHANGES***

During the 2005 annual meeting of the UAUS Council of Local Presidents, it was proposed that the Membership Committee Chair position be added to UAUS Governing Board. The purpose of this is to allow the Membership Chair access to the UAI database to access membership information for updating the database and researching of memberships.

Adding the Membership Chair to the Governing Board also entitles the Membership Chair to Governing Board voting privileges, and therefore it was determined that the Membership Chair should be elected by the Council of Local Presidents and Vice Presidents (CLP) rather than appointed by the GB as is the current policy. Additionally, becoming a Governing Board member confers the responsibility to be present for, and to participate in, all shared responsibilities and requirements of other Governing Board members.

A vote by the CLP will be conducted at the end of the required 90-notice on March 20, 2005. # URANTIA FOUNDATION

## Urantia Foundation's Translation and Revision Projects

In early December the first truck-load of the newly printed Das Urantia Buch, the German translation, reached the Head Office of Urantia Foundation. Once the copyright has been secured, the distribution of the German book can begin in earnest. German is spoken as first or second language by some 124 million people; it is the national language of Germany and Austria and one of the four national languages of Switzerland.

Das Urantia Buch is the Foundation's eighth printed and tenth available translation. The other available printed translations are: French (1963; full revision 1994; 126 million speakers), Finnish (1993; 6 million), Spanish (1993; 401 million), Russian (1997; 280 million), Dutch (1997; 21 million), Korean (1999; 76 million), and Lithuanian (2004; 4 million). The Portuguese (2003; 186 million) and the Rumanian (2004; 30 million speakers) which are still preliminary are available only on CDs. The Italian translation will soon be downloadable on the Foundation website.

The next translation to go to the printing press is the Italian (62 million speakers). The work is ready to be published, but its distribution has to be organized before the printing may start running.

The Swedish, Estonian, and Polish stand next in the line. These three translations are at their final stages of improvements and refinements.

Translations on which work is still in progress are: Farsi (Persian), with 47 papers completed; Japanese with Part IV and second part Papers 57 through 83 completed; Chinese, whose translators have the first draft of Parts II, III, and IV completed and are currently working on Part I, refining at the same time the first-draft papers; Greek with the first draft of the entire book completed and work on perfecting the first draft progressing acceptably; Czech, which was launched hardly a year ago and comes with 19 first-draft papers completed. Other translation projects include Bulgarian and Indonesian, which are progressing slowly.

There are good chances that an Urdu translation effort can be launched in near future. The Foundation is also sponsoring efforts to revise the existing Spanish translation and to refine the Portuguese and Rumanian translations so to get them into shape fit for print.



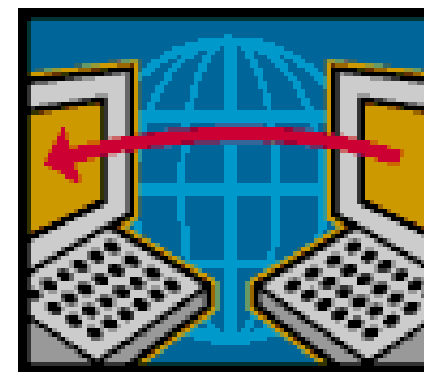

## *Interview with Seppo Kanerva President of the Urantia Foundation*

By James Woodward

**James Woodward:** Can you tell us about some of the responsibilities you now have as President of the Trustees.

**Seppo Kanerva:** When I became President it was exactly a year ago I made a short statement after the election that I don't pretend to be a great leader. What I try to accomplish is that I am a team player, I don't imagine that I would be the sole person to lead this enormously important project I need support, I need people around me, of course my fellow Trustees. I am very keen on that it is my major focus to keep the team together and to work as a team.

Apart from the Trustees we now have four Associate Trustees and two Trustees Emeriti. We are really a great team. The five Trustees have their opinions, their views, their understanding, but the pool of perspective is much larger now when we have the Associate Trustees and the Trustees Emeriti. It is hard to overemphasize the importance of these close associates who are involved in everything the Trustees do. There are truly very few issues where I need to limit the discussion to concern only the five Trustees. Whatever the five Trustees then decide amongst themselves is shared freely with the Associates and Trustees Emeriti. As a team, we are now approaching the time, in my personal opinion, and the moment is here now, when we all realize, especially during this weekend meeting, that we are a team, we are a team. I sensed for the first time, a genuine and sincere effort by each and every one to be a good member of a team.

One of the lessons in The Urantia Book is that what we have to learn here is teamwork. And that there are very few assignments in the universe that are solo that a servant can perform. Almost everything that happens in the universe is the result of teamwork. I think, and I believe that we are at this moment, realizing this in a very tangible way. Of course everybody has known about this at the mind level, but I see that now it has sank into the hearts of everyone.

**JW:** Are you still serving as Manager of Translations? And can you give us an update on translations in progress.

**SK:** Yes, I am still functioning in the role of the Manager for Translations. That is an area where a lot is happening. We are currently ready to publish in one form or another, the Italian translation. It has been formatted to be published as a book but we are also formatting it to be published on the internet, on our website, along with so many other translations. The Italian work came to a close, finalized a year ago, now it is ready to be made public. Just recently we published the Lithuanian translation - it exists in book form and is finally distributed in Lithuania, after so many troubles and difficulties but we have it finally. Then, with regard with those works that are soon to be published we may count also the Portuguese translation; it is in the stage of being formatted. The German translation we detected spelling mistakes and discrepancies, minor things like that, the corrections work will be finalized by the end of this month and then the formatting process may set in. So we have three major translations to be published, the Italian, the Portuguese, and the German will be published this year.

The work on the Chinese is going very well. Parts II, III, and IV exist in the first draft form. The team is currently working on the Foreword and will then go on to part I. What this team is also doing is they are also checking what has been translated so far, correcting and improving it at the same time as they translate the Foreword. I have great admiration for the Chinese team especially,

## *ISB DISSEMINATION COMMITTEE REPORT*

This committee wrote articles on the prison placement project for the June and September issues of *TIDINGS* newsletter. This netted financial support and several offers of help from within and without UAI.

We also submitted request to CFO for \$2000 to be allotted this committee in the 2006 budget proposal for seeding books.

Reader referrals were received from Argentina, Australia, Brazil, Cameroon, Canada, China, Colombia, Costa Rica, Ecuador, England, Finland, Germany, Lithuania, Mexico, Netherlands, Panama, Philippines, Peru, Spain, Sweden, Switzerland, and the US. We also received and responded to 52 prison inquiries to the PIRT.

This committee produced a document titled "Letter of Trust Regarding Referrals" in English and Spanish for publication in the "Local President's Notebook" concerning the proper use of readers personal information and safe guards for reader privacy.

Copies of The Urantia Book were sent to a study group leader in Indonesia who sent an email seeking contact with other readers.

We wish to recognize the Oregon Association for all their work and support of the prison and other UAI projects. Joy Brandt has added two volunteers to respond to letters from inmates who have already received a book from the PIRT program.

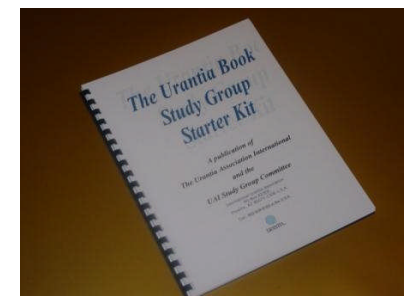
## *ISB STUDY GROUP COMMITTEE REPORT*

In two months, over 20 kits have been delivered and at least three new study groups have been created; one in India, one in Texas, and one in California. Other groups are in the process of forming. The kit was translated into French and Spanish thanks to other UAI members in France and Spain.

Several study groups have been added to the UAI database along with the names of people looking for study groups. So far, our goal of submitting an article featuring a study group from around the world each month to the Tidings newsletter has been accomplished. We encourage everyone with a group to send us a photo and a brief description of your group to us. We feel that it is very important to share this information to encourage others to form their own groups.

This committee is looking for a volunteer to take over the printing and mailing of the study group kits. All expenses are reimbursed.

One of our goals for 2006 includes developing a program to pair study groups together to directly support one another in study efforts.

We extend a hearty and warm thank you to all who responded and especially to our anonymous friend who prefers to enjoy our progress from the sideline. This challenge was inspired by the recent announcement of the Study Group Starter Kits from the Study Group Committee of the UAI International Service Board. This anonymous person is pleased with our progress for fostering study groups and especially with the commitment to promote and support study groups to all readers of *The Urantia Book*.

The incorporation of UAI is on hold until we have a new Bylaws document that is updated to remove references to former Urantia Brotherhood Association. Resolution 2005-15 Charter/Bylaws Changes was presented to the Board for discussion on October 25, 2005. This resolution to amend the bylaws was passed on Nov. 25, 2005.

The ISB recommended to the RC that we should establish two new restricted funds, an UAI Conference fund to receive and disburse funds contributed specifically for the process of conference production, and the UAI Conference Scholarship Fund, to receive and disburse funds contributed for the purpose of making grants to individuals who need financial assistance to allow them to attend conferences. The procedures for managing the funds shall be established by a committee comprised of ISB Conference Committee Chair, ISB Treasurer and one or more members of the ISB and/or the RC. It shall be the responsibility of that committee to determine the administrative measures required to manage these two accounts. Since it may take some time for all policies and procedures enacted under this resolution to be put into place within the UAI, and as it is important for the process of soliciting funds for scholarships for the 2006 International Conference, this resolution provides that ANZURA (New Zealand and Australia Association) is authorized to solicit funds and place those funds in their own scholarship/sponsorship account or in the UAI account established under this resolution.

The ISB also approved requiring one authorized signature for all checks, drafts and financial orders in accordance with the Bylaws Article VI, Section 6.1.3.c for amounts not to exceed \$10,000. For any transaction amounts exceeding \$10,000 for any one specific and identifiable project or program, including those requiring more than one financial instrument for completion, the president or vice-president shall also sign each check, draft, or order for that project or program.

because the Chinese language is so completely different from the Indo-European languages. It is a great, great challenge to translate a text as complex as *The Urantia Book* into a language where you don't have subordinate clauses, where you can hardly make a distinction between the singular and the plural, the present and the past tense and so on. Of course this it can be expressed but it is so difficult and complex that the work must be very difficult. No speaker of a European language can imagine how difficult it is to translate into Chinese.

And another Asian language, the Japanese translation, is progressing steadily and very well, thanks to one translator and her assistants. The Japanese translation has advanced to the stage where Part IV is ready and now the translator is working on Part III. It's interesting to note how translators tend to begin with what they conceive to be the easier parts. And then the third part of the book which is not that difficult. And then they tackle the Foreword and Parts I and II, which are more difficult.

Going back to the Indo-European languages, the Swedish translation is also finalizing, or refining, is progressing steadily. I am personally part of that team. We have covered so far, the Swedish translation exists in its final form from the Foreword to page 79 now. The Estonian translation has been in the making for ten years now. They are also now at the final stage of refining and correcting, analyzing the text and we expect them to be finished sometime next year. The Polish translation exists at first draft level, the entire book, and a lot of refining has also taken place. With that translation we are at the stage of getting it assessed by independent, educated Polish speakers. The Czech translation was launched about a year ago. The team is of the type where the people are not retired, they are actively involved in their daily jobs so they perform this translation only in the evening hours and free time, so it is understandably progressing pretty slowly. But they are working steadily as well. And then we have the Bulgarian translation, where unfortunately the original team did not get along, so we have only one translator left who is desperately looking for people who could assist him. He has 27 papers translated.

The Greek translation was completed in the year 2001. There was a standstill because the person who was in charge of the project had no time for the corrections and refining of the text. But now, a few months ago he managed to get two highly educated persons to assist him. And both of those people are actually readers of *The Urantia Book*, so we have a fortunate situation there. One of them is a university professor and the other person also works in a teaching capacity so that translation is in good hands now.

**JW:** [Can you give us an update on overall Foundation business news, especially as to financial health?](#)

**SK:** Well, most of that came up in the discussion of translations, of books to be published. We are currently printing the English book, a new printing. What is remarkable with that is that we need not determine in advance how many hard cover or soft covers we print. They are going to be bound on demand. We are currently having the situation where that there are more hard covers than paperbacks and the demand for the hard covers is considerably more than the paperback, which is something that we could not foresee. Also we went to print the third printing of the Russian book. The printing happened in St. Petersburg in Russia. Unfortunately the book will be nine centimeters thick because the printer cannot print on the thin paper, the so-called Bible paper. But we have been told by our Russian friends that it is not a big problem, because in Russian readers tend to think that the thicker a book, the more important it is. You can have a nine centimeter book; it must really look like an impressive book! [Laughs] The Italian needs to be printed and we have a person who has promised to raise the money for that. The German needs to

be printed and we have two persons who have promised to raise the money for that. So we are safe with that respect and we can safely proceed with these two printings. There are people who are busy raising the money to print the Portuguese book. So there's good hope that we can print the Portuguese book. We recently made public the MP3 audio version of The Urantia Book. Of course we understand that it has limited demand because people don't have the facilities needed, but we consider that it's important that we can have it available. Instead of the very cumbersome 96 tapes we have six CDs to listen to.

Money is always short. Due to the situation that money is short we were forced to unfortunately, reduce staff, which is really deplorable. But we are happy to see that we can manage shrinking, with this staff that we currently have. But of course we need more hands, and also paid hands to help us. We are currently in the process of hiring a sales manager. We understand that as long as we are a book publisher we better do it properly and we need to be interested and concerned about distribution and sales of the book. You can do it but it is not properly done if it is a sideline, a staff person's sideline. We need a person who can concentrate exclusively on the distribution and sales of the book all over the world. But of course the US market is the major market so that's where the sales manager will need to concentrate. I need to underscore not only in the US market but the translations need to be kept in mind and the markets explored and ways found out how to get into the distributors in those countries or areas where the suspecting language is spoken. There is a lot for the sales manager to do and we understand that only one person can do so much. But there is enough that we estimate someone can help us in that area. Those are the major highlights concerning the business aspects. The money, the fundraising, is always an issue that is discussed at every Trustee meeting, which happens not only quarterly at the face to face meetings but we have telephone meetings quite often. The financial situation is explored and studied at every meeting either by telephone or face to face. The dollar a day campaign that was launched a little over a year ago is very interesting. It is mostly done by one trustee who calls people on our mailing list one by one. His ambition is to go through the entire mailing list. It is always intriguing and sometimes uplifting to listen to his reports on the progress of this project. What the response is, most people called, according to him respond positively, but of course it is not a surprise that he gets also negative and hostile responses sometimes. But it is a project that is giving us steady income because these people who are called and who respond positively pledge to give a dollar, or a Euro in Europe, which means \$360 dollars a year. What is also remarkable is the number of small donations is on the increase constantly. What we are short of is really big donations. This does not mean that we are not extremely grateful to the small donations. We understand that not everybody can give a million dollars or even a hundred thousand. Even one dollar a day is something that we are grateful for.

**JW:** It appears that Urantia Foundation has been running very quietly, what can we look forward to in the way of guidance and leadership?

**SP:** What may seem to have been quiet is maybe a choice. The Foundation was constructed by the revelators, all those superhumans who were in charge of the revelation, instructed the early leaders that we need not, we must not, seek publicity and rely more on the silent spread of the teachings and distribution of the revelation in the book form or other forms that are currently available, either electronic or otherwise. Maybe it looks strange but it is that way. I receive every so often calls from people who have recently discovered the book and have been reading it and are overwhelmed by the teachings and almost invariably say, "Why don't you advertise it? It is such an earth shaking and important work, why doesn't anybody know about it?" We were instructed that the

revelation was given to us well before its worldwide impact so we take it that we need to proceed slowly but steadily and securely to create the basis for a solid basis for this revelation to take fruit. And only then can its transforming impact on the world be genuine flashy attention can be drawn to it, there's no question about it, with modern technology and advertising, we could make it known within days all over the world. But that is not what we were instructed to do. We need to create a solid basis, slowly, surely, and securely. What we are trying to accomplish is to overcome a rift that has been the plague of the readership, the movement as a whole, for so many years, for more than fifteen years. We have tried to accomplish a friendlier atmosphere. Understand that we must not act in a pushy way if there is to be a feeling, to overcome that rift, it needs to happen sincerely, it needs to happen peacefully. We cannot force people to change their minds but we can always act as an example. And we are still in that process, within the Foundation itself, we try to overcome that rift. And in my very personal estimation, as I said in the beginning of this interview, we are making steady progress. We have always understood on the mind level that we are a team but now especially during this weekend meeting I saw it affect our hearts. If we act in a pushy way it will fire back we will just simply create more dissention and more disunity if we don't act silently, peacefully, and in a non-spectacular way. That is how we understand this. There is no question about it, that is one of our expressed goals and objectives to overcome. Sometime ago we made a formal decision, a resolution, that the Foundation would raise from interfering with the internal affairs of any reader organization, any social organization, and why we don't have formal ties with the Fellowship of course, concerns the IUA. We don't want to interfere with the internal proceedings and affairs of IUA. The Foundation has not interfered much in the past but now we want to formalize it so that we cut all formal and legal ties between the Foundation and IUA. It may be that members of IUA do not know about it but the fact is that the board of Trustees as individuals, members of the board of Trustees, are also the board of directors of the UBA, doing business as IUA. And it is our policy and we are going to implement that policy that even that tie will be cut. The foundation trustees, not as a body, nor as individuals, will have formal or legal ties with IUA needs to be fully independent. There is some paperwork to do with regard to that and the issue is complex.

**JW:** What is the overall vision of Urantia Foundation in the next five years?

**SK:** The traditional activities of book distribution, their dissemination, the translation, the reprinting, dealing with the physical aspects of the revelation, while the word was given and made book, of course continues to be our primary and first concern. In five years time I think there will be documents, memoranda, about the various ways on how to proceed with that task, which is actually of a primary objective, the secondary objective is the book itself. In five years time I'm sure there will be a few more translations to print. There will be a lot of developments in these modern ways of disseminating the teachings, besides the internet, facilities and means, maybe other electronic gadgets who knows what the technology holds for us in five years time. And how to use those new methods and means will be challenging but it also belongs to the secondary objective of the foundation concrete physical dissemination of the teachings. The real challenge is the more abstract dissemination of the teachings which form the other ways to transform the world.
